The regular meeting of the Board of Education of Independent School District No. 484 was held on Wednesday, April 30, 2025 in the High School Media Center. The meeting was called to order at 6:00 PM by Chair Matthew Hoheisel.

Every such acceptance shall be by resolution of the governing body adopted by a two-thirds majority of its members, expressing such terms in full."; and
